THE PURPOSE AND EFFECT of the proposed Consent is to sever a rural backlot, with frontage along Highway 518, and create a new shoreline lot. A large parcel will be divided into two new lots: a rural lot and a shoreline lot. The two shoreline lots will have 108 and 173 metres of waterfrontage, and areas of 1.3 and 1.6 hectares. They will be accessed by a ROW over Hawksview Lane. The rural backlot will be 7 hectares, with close to 200 metres of frontage on Highway 518 and frontage on a private road.

As a component of the application, a privately held island will be deeded to the municipality to ensure there is no new net development on the lake.

THE PURPOSE AND EFFECT of the associated Zoning By-law Amendment is to rezone the island to Open Space, rezone the rural lot to Rural, implement the recommendations of an EIS, and rezone the shoreline lots to an LSR zone to implement the recommendations of an EIS.

If a person or public body has the ability to appeal the decision of the Township of Seguin in respect of the proposed consent to the Ontario Land Tribunal but does not make written submissions to the Township of Seguin before it gives or refuses to give a provisional consent, the Tribunal may dismiss the appeal.

If a person or public body would otherwise have an ability to appeal the decision of Council to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Seguin before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Seguin before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

If you wish to be notified of the decision of Council in respect to the proposed consent and zoning by-law amendment, you must make a written request to Council. Please be advised that your comments and submissions should be addressed to Council, care of Craig Jeffery, Clerk, and will be considered as public information and become part of the public record. Figure 1: Key Map

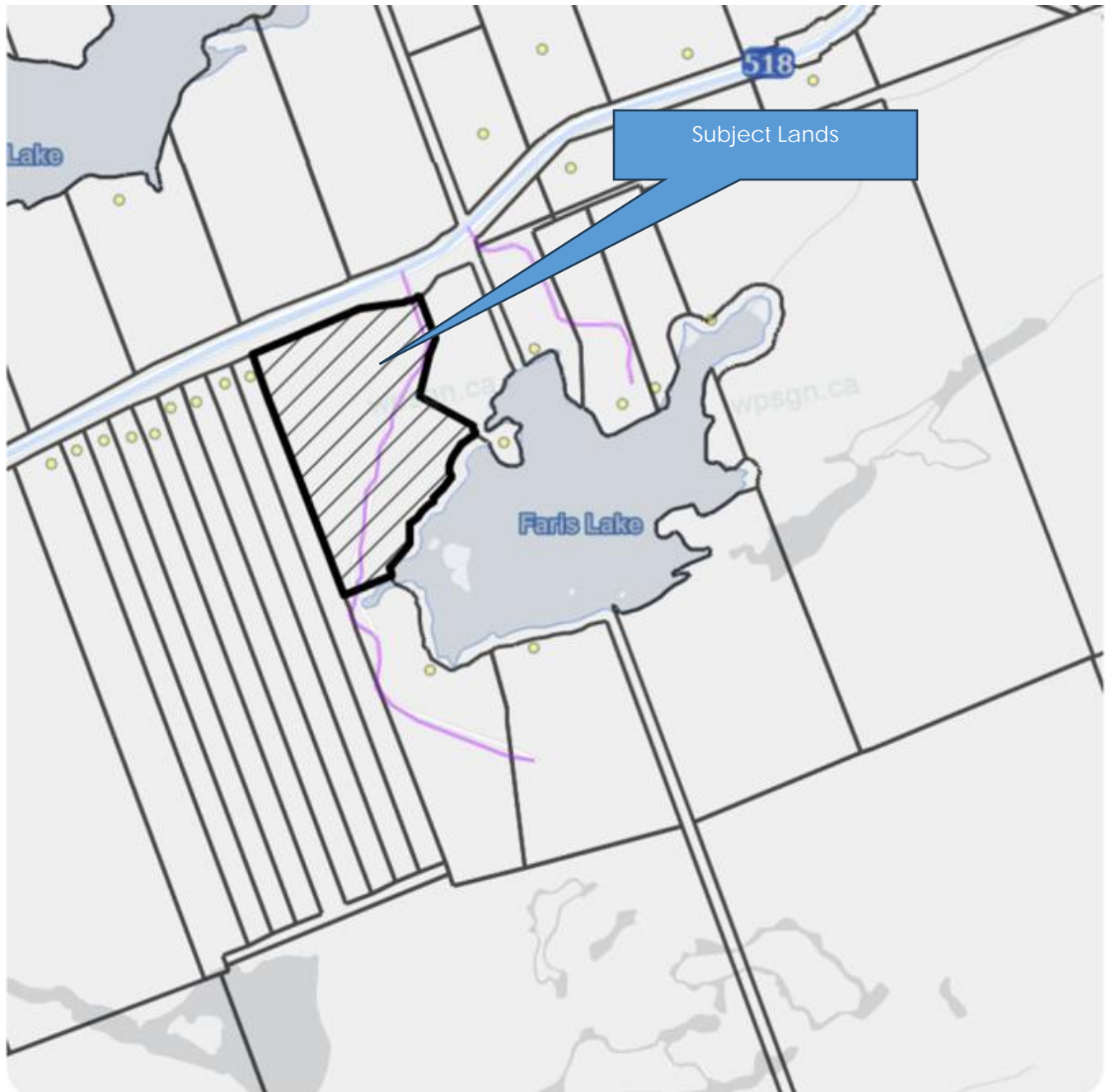


Figure 2: Site Sketch
